The following is a summary of CalPERS Circulars, relevant to payroll, distributed during the month of December 2018.

# 1) CalPERS Circular No. 200-064-18 – 2019 Annual Invoice for IRC 415(b) Replacement Benefit Fund (RBF)

- The 2019 Internal Revenue Code (IRC) 415(b) annual dollar limit has been increased from \$220,000 to \$225,000 for retirees aged 62 or older.
- The Annual RBF Invoice, covering 2019 calendar year, has been issued in December, and can be downloaded via the Cognos reporting tool on the myCalPERS website.

Subject: 2019 Annual Invoice for IRC 415(b) Replacement Benefit Fund (RBF)

### **Purpose**

The purpose of this Circular Letter is to inform you of the 2019 Internal Revenue Code (IRC) 415(b) annual dollar limit. The limit has been increased from \$220,000 to \$225,000 for retirees aged 62 or older. The annual limit is reduced for people who retire under the age of 62.

#### **Annual Invoice**

Annual invoices, which cover the 2019 calendar year, will be issued in December 2018. The invoice due date is 30 days after the issue date of the invoice; however, if you are able to pay your invoice in full by December 31, 2018, this will ensure your retiree receives payment on February 1, 2019, with no delay in their monthly benefits.
