Purpose

The purpose of this letter is to inform you that the 2018 Annual Member Statements (AMS) will be available to your employees beginning October 8, 2018.

Statement Availability

Employees can access their statements, by logging in to their my|CalPERS account at my.calpers.ca.gov. The AMS will include the member's CalPERS account information as of June 30, 2018, including:

- Accumulated service
- Contributions and interest
- Employer(s) name
- Retirement formula(s)

If your employees receive their AMS by mail the statements will be sent out the second week of October.

Present Employer Statement Report

For employers, the *Present Employer Statement Report* is available to generate on demand in my | CalPERS. This report displays summarized AMS information for your employees, including:

- Current contributions
- Posted interest
- Total service credit
